SUB: Clarification on the term 'Duty' under Sl. No. 3 of Appendix-3A of Foreign Trade Policy 2015-2020 –reg.

Attention of the exporters, importers, custom brokers and all concerned is invited to the Public Circular No. 07/2015-20 dated 23.05.2018 issued by Directorate General of Foreign Trade (DGFT) on the above subject.

2. The Appendix- 3A of the Foreign Trade Policy 2015-2020 (FTP) is a list of items not allowed for import under Export from India Schemes under Chapter 3 of FTP, unless otherwise specified. A copy of the same is enclosed for reference. Vide the said Public Circular dated 23.05.2018, the DGFT has clarified that:

"the term "Duty" used in respect of the items listed in Appendix 3A is to be read as "Basic Customs duties" only and not "all Customs duties (including BCD+SAD/IGST)."
